Thoughts about Supreme Session from Princess Tirzah...

This being my fifth Supreme Session, I have to tell you, no two are alike! I have thoroughly enjoyed each and every one. And like many aspects of life, the more you get involved, the more fun you have.

This was my first Supreme Session as a line officer. Thanks to a suggestion by our Princess Banker Susan Coulter, I spent a good portion of Friday, Saturday, and Sunday working in the Supreme Princess Badoura booth with Cathy Rose's mother, Carol. It was a wonderful opportunity to meet lots of new people including many of my counterparts. Cathy and her crew did a wonderful job of finding items with mass appeal. By Saturday afternoon we were informing many potential customers that we were "sold out" of various items. To anyone considering a position as a line officer, I would strongly advise getting involved as much and as early as feasible.

Friday evening I discovered that I was certainly with the right group of counterparts. The Princess Tirzahs met for an evening at "The Diner" which was closed to the general public and had prepared a special menu just for us. We emerged four hours later, still laughing, still singing and much better friends. Cathy Rose and the Princess Tirzah officers are certainly doing their part to put the **fun** back into Daughters of the Nile. In fact, one of Cathy's mottos which can be found on her T-shirts is: "We have fun so the kids can run."

I am certain that the opening ceremony was magnificent; however, when I returned to the campground to change into my formal, there was a sudden surge of strong winds, pouring rain along with a threat of hail and flooding. I opted to remain at the campground. This was just the first of the severe storms we experienced during the week. I won't bore you with the details here, but our motorhome is now scheduled to have the roof replaced in August.

I am so pleased that Alabet was so well-represented at this Supreme Session with all the line officers, twelve Past Queens, and two LOH delegates (also three non-voting LOH)!!! We had some significant legislation during this session; some of which had been brought forth in the past. These decisions are difficult as we move forward and try to maintain the quality of our rich history and yet keep up with the changing times. Such a balance is not easy and requires thoughtful consideration of each carefully placed word. No doubt some members walked away feeling we're changing too fast and/or in a wrong direction and others believed we are moving forward too slowly. With much of this legislation, there are no easy answers, no one way of doing things.

During the Princess Tirzah luncheon on Wednesday, each of us shared how we "Cleopatra'd" in our temple. Many had good suggestions and shared traditions from their temples. At least one of the ideas is something I hope that Alabet will adopt as a new tradition. I'm not going to tell you here what it is, but at a future session if you notice something new, let your line officers know if you like it.

I would be remiss if I did not share a bit of Navy's experience with you. First of all, he is the first male to my knowledge to sit through a Supreme Session. Having so recently taken on the role of service dog, I thought he did very well. I was both pleased and disheartened when I learned that there were two other members of Daughters of the Nile who had service dogs, but they had been concerned about how the dogs might be perceived and had chosen to leave their service dogs at home. We are after all an organization whose ONLY philanthropy is Shriners Hospitals for Children® which cares for children with various disabilities; why wouldn't our own members with disabilities be accommodated? I hope that our next Supreme Session includes additional service dogs.

Of course, raising money is always a given. The Princess Tirzahs will be selling raffle tickets for a six night stay at the J.W. Marriott during the **2016** Supreme Session to be held in Indianapolis, Indiana. The raffle tickets are \$10 each; I will do my best to have tickets available at each session. All hotel rooms, meeting rooms, entertainment and other activities will take place under one roof. The dates will be June 15 to June 19. Save these dates! 2014 Supreme Session Legislation Update

At the May Session I presented the legislation with previous notice, grouping similar topics together and asking for feedback from the Ladies of the Household for voting members going to Supreme as your representatives. All decisions that passed will be worked through for working and/or conflicts within any of our publications of bylaws, rules, and regulations. The final report is expected in the fall. In the meantime, this is a summation of things that passed and one key decision made by a Supreme committee following the request for an opinion at the April meeting.

First, the decision was handed down by a Supreme committee subsequent to the opinion poll that all Ladies of the Household may (and actually some Temples have already allowed) wear Pantsuits and dress pants to session. An amendment to this was attempted but failed to change the dress code requirements for the 19 officers to tea length or longer from ankle length or longer.

The amendment to change membership criteria to allow a friend of a Daughter of the Nile failed, as did membership with no affiliation with a Masonic body but the amendment to allow membership to a past patient passed.

Failing to pass also was the amendment that all Daughters of the Nile in Good Standing who are registered and in attendance at an Annual Session would be voting delegated; however raising the number of voting delegates at a Supreme from two to five passed.

Changing the requirement for the Secret Work at each Session to a minimum of three times per year -- at ceremonials and the Supreme visit -- failed.

Changing the number of rituals a Temple has to purchase and make available to four passed and included with that amendment is a change that the Recorder is responsible for them rather than the Queen.

Passing after a good deal of discussion and clarification was an Obligation Only initiation.

The formation of a Supreme Temple Convention Committee to assist with negotiation and contracts with the Supreme Session hostess city chosen by the Supreme Princess Badoura was passed by a huge percentage. By the fall the final wording and clarification of those amendments that passed should be sent to our Temple.


